WORKSHOP #2 - STRATEGICALLY INTEGRATING BRIGHTFIELDS INTO EPA BROWNFIELDS GRANTS

In this workshop, participants learned about strategic ways to include clean energy reuse in EPA brownfields grants and to use certain tools to evaluate site potential for reuse.
